Planning & Approvals

Development Application

We have now lodged our Planning Report for our Development Application with the Old State Assessment and Referral Agency (SARA) for review before being published. It must comply with State Code 16 (Native vegetation clearing), State Code 23 (Wind farm development) & the Planning Act 2016.

We will have a copy of the Planning Report available for the public to review and discuss with us at our next round of drop-in information sessions (details above).

Referral under the Commonwealth Environment Protection and Biodiversity Conservation Act 1999

The project is being referred by us to Department of Climate Change, Energy, the Environment and Water (DCCEEW) for review under the Commonwealth Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act). Once the referral has been accepted and uploaded to DCCEEW's portal, we will provide a link to this on the Approvals tab on our project website <https://www.moahcreek.com/>. On that same page, we will also provide clear information as to how anyone can make a submission during the public comment period (that runs for 10 days). As soon as we receive notification as to the date range of the 10 day public comment period, we will post that information on our website and notify all of the stakeholders in our database by email or text.

We will have a printed copy of this referral available at our next information sessions (details above).

Engagement & partnership with the Darumbal People

In our next newsletter we will provide a summary and update on our engagement and partnership with the Darumbal People to include cultural heritage assessment, cultural awareness training and the negotiation of an Indigenous Land Use Agreement (ILUA).
